5 Public Participation

The monies have been received from the Police Community Fund and Cllr Hopwood has ordered and received the litter picking equipment which he is kindly storing at his home. It was decided to defer organising a volunteer group until July meeting. Included in the monies received from the Police Community Fund was an amount to purchase a speed gun to be used jointly by neighbouring parishes. The speed gun is currently unavailable from Amazon and therefore other suppliers are being explored.

i) National Planning Forum Meeting: Cllrs Shannon and Hopwood attended the meeting hosted by CWaC. Unfortunately, nothing new to report particularly with regard to Neighbourhood Planning.

13 Christleton Village Plan

The Cycling, Walking and Traffic Plan proposed by Christleton Parish was supported unanimously by the Parish Council and the Chair requested the Clerk to convey this to Christleton Parish Council.

14 Neighbourhood Watch

A local resident who has been recently burgled asked if a Neighbourhood Watch scheme could be set up. It was felt that during the current conditions it would be difficult to organise due to the formal requirements of a Neighbourhood Watch Scheme. It is recognised that most people have access to social media outlets such as WhatsApp and Facebook to communicate instantly with each other. The existing Rowton Support WhatsApp Group would be able to extend its membership to fulfil the function of neighbours instantly sharing information and concerns about suspicious activities etc. The Group organiser Andrea Wright requests that anyone interested in joining the Group contact the Parish Clerk with their contact details for onward transmission to her.

15 Hope House

The Council discussed the request for a donation but regrettably resolved it was unable to donate to a charity that was outside the parish boundary. Action: Clerk to inform Hope House charity of decision

16 Christmas Tree

The Parish Council, after careful consideration, decided that it would be impractical for a rooted Christmas tree to be planted on the Village Green. Apart from the cost, the location is unsuitable as it would be positioned near to the Oak tree which would be detrimental to both trees.
